

I am to state that the General Body of this council at its meeting held on 28/03/2014 considered the Compliance along with Council assessor report (August, 2012) on the standard of examination and other teaching facilities available at Padmashree Dr. D. Y. Patil Medical College & Research Centre, Pimpri, Pune for purpose of Recognition of MS(ENT) qualification against increased intake from 1 (One) to 2(Two) granted by Dr. D. Y. Patil Vidyapeeth (Deemed University) Pimpri, Pune.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

The Postgraduate Committee considered the Compliance along with assessment report (August, 2012) and decided to recommend that MS(ENT) qualification against increased intake from 1(One) to 2(Two) granted by Dr. D. Y. Patil Vidyapeeth (Deemed University) Pimpri, Pune in respect of students being trained at Padmashree Dr. D. Y. Patil Medical College & Research Centre, Pimpri, Pune be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Council further approved the following recommendation of the Postgraduate Committee as ammended:

"The Postgraduate Committee further decided that the attention of the institute be drawn to Sections 6 (4), 6 (5) & 6 (6) of Postgraduate Medical Education Regulations, 2000 as amended by amendment notification"Postgraduate Medical Education (Amendment) Regulations, 2009 Part-II" dt. 21/07/2009 and act appropriately at appropriate time which read as under:

(4) The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(5) The procedure for Renewal of recognition shall be same as applicable for the Award of recognition.
